3. *the equipment has clear and concise instructions for launching procedure and in the case of raft packed in a valise, an instruction card encased in clear durable material,*
4. *the equipment contained within the raft is according to SAMS policy and guidelines and SAMS approved (small vessel pack and the appropriate warning on the outside of the container);*
5. *the equipment remains fit for use whilst in service;*
6. *and the life raft and equipment are serviced by an authorized life raft service station.*

This certificate remains valid until the date stated hereon, unless canceled or revoked by the Authority, which may withdraw this approval at any time for reasons of non-compliance with the applicable regulations referred to in this Certificate of Approval
